The person to fill this form must be between **30-70 years** old and **MUST** be any of the following;

1. Senior Civil servant, Grade level 12 and above.
2. C.E.O's, of a reputable registered business with Corporate Affairs Commission.
3. Practicing professionals.
4. Equivalent of senior banking officer in Banks and Deputy Manager of a reputable company.
5. N.B any other level of guarantor in conflict with the above stated level is not acceptable.

Guarantors are warned that any false declaration on this form will attract severe consequences, which may include prosecution.

A copy of guarantors **Driver's license** or **international passport** and **current place of employment MUST BE** submitted alongside the form.
